In consideration of Financial Fitness & Insurance Services, llc to design/build and maintain a website for above named agent, it is agreed upon as follows:

1. Outline of Agreement & Website Rental

The above-named person (hereinafter referred to as the "agent") hereby engages Financial Fitness Insurance Services, LLC, (A Nevada Corporation, hereinafter referred to as Financial Fitness and or Advisors Integrity Financial Group), for a specific designs and use of its company branding website, "Advisors Integrity Financial Group" for use by the named agent. (Only for the purpose of and while representing Financial Fitness & Insurance LLC / Advisors Integrity Financial Group products exclusively*).

Financial Fitness hereby agrees to contract with its web designer for the building and preparation of an exclusive replicated, "Advisors Integrity Financial Group" website for the benefit of the above agent and agrees to assist the agent in personalizing said website for agents exclusive use (limited only to the HOME PAGE, HOME PAGE TITLE, and ABOUT US PAGE), with all other pages to be duplicated "as is for agent's personalized use of the website.

Agent and/or business listed above acknowledges that the services rendered under this agreement shall be solely as an independent contractor, It is expressly understood that this undertaking is not a joint venture.

Agent/business listed above agrees and understands that the website is the exclusive property of Financial Fitness and that Financial Fitness considers this to be a valuable asset of its business, Furthermore agent/business acknowledges and understands that all copyrights to the website and work product produced shall remain the exclusive property of Financial Fitness. Agent/business will not copy, sell, transfer, publish, disclose, or otherwise make the work product available to any third parties without express written consent of Financial Fitness. Right to the finished assembled work of the web pages produced by Financial Fitness is owned by Financial Fitness accordingly. This includes domain names, all photos, graphics, text, source code, videos, work up files and computer programs are not transferred to agent, for the exception of pictures and/or text provided by the agent to Financial Fitness in the exclusive development of agents/business personalized pages as mentioned above.

Additionally and from time to time Financial Fitness may make changes and/or adjustments to the site for updated information or product changes. If agent desires additional personalized changes, those changes must be submitted in writing to Financial Fitness for approval and will be made upon approval at agents cost if any.

2. Pricing / Termination

Any Cancellation prior to the 12 months will be billed at the normal rental rate for each remaining month of this rental contract. This contract may be terminated by Financial Fitness during the initial 12 months upon receipt of information confirming that the agent/business has been writing primary life and/or annuities outside of the scope (product) that Financial Fitness provides. Any remaining months unpaid at the time will be billed to the agent/business, all due and payable upon receipt of notice.

If Financial Fitness does not receive payment within the agreed payment period of the date of any invoice, it may terminate this contact as regards to non-payment and will be sent to collections.

After your rental term has finished (12 months) 30 days notice (via written or e-mail) is required to cancel the contract. If you wish to continue renting the website you will need to do nothing, Financial Fitness will continue on a month-to-month basis, Your cost won't go up (unless there are additional fees to Financial Fitness to maintain the website)

While it is not expected that any change to the pricing will be made. Financial Fitness guarantees all cost to remain as indicated in the attached fee schedule for the initial 12 months. Hosting company and/or web designer and all parties have acknowledged that should any change in pricing occur, that agent/business will be provided with updated prices, and have up to 30 days to opt out is desired. At that time, all ownership rights of said website will revert back to Financial Fitness.

Upon termination Financial Fitness will retain full name ownership of and all rights to any free domain name registered by Financial Fitness, irrespective of whether the domain name is the clients name or business name. The website (including both design and wording) and any variations thereof shall remain the sole property of Financial Fitness during the term of this agreement. Upon termination of this agreement and thereafter, the agent/business will not obtain any right to the Financial Fitness website.

Any Rights granted under this agreement to agent/business shall not affect Financial Fitness exclusive ownership of copyrighted work. Agent acknowledges that at no time are they permitted to enter into an agreement under or incur debt or obligate in any manner under the name of Advisors Integrity /Financial Fitness Group. Agent/business also acknowledges that they have been presented with this agreement in advance creation of the personalized rented website and has entered into this agreement of their on volition.
